2. The trust is registered with the following objectives:
 - a. To establish pathasalas, gurukulams and such other traditional seats of learning and to impart education and disseminate knowledge in the Vedas, Upanishads, Puranas, and any other books or sources of knowledge of Indian or other origin.
 - b. To establish research centres and other facilities to undertake research in the field of Veda, Upanishads, Puranas and such other ancient texts.
 - c. To establish, maintain and manage Nursery Schools, Primary Schools, Middle Schools, High Schools, Secondary Schools, Colleges, Professional colleges, Vocational, Technical and non Technical Institutions of all kinds with or without hostel and boarding facility including Research Institutions for good quality education and advancement of knowledge to needy, deserving and meritorious students in particular and the general public.
 - d. To promote special consideration and infrastructure in women's education with a goal to achieve empowerment of women.
 - e. To promote Indian arts and culture among the student public with a view to bring national integration and the spirit of patriotism among the young population of the country in specific and all countrymen in general.

- f. To grant individual or group scholarships for poor, deserving and needy students at all levels of education.
 - g. To run, maintain or assist any medical institution, nursing home or clinics or to grant assistance to needy and indigent persons for meeting the cost of medical treatment.
 - h. To give financial or other assistance in kind by way of distribution of books, notebooks, cloths, uniforms, or meals for the poor and indigent and to the persons suffering due to natural calamities.
 - i. To set up libraries, reading rooms, community centres to be available for public use.
 - j. To conduct training classes, seminars, discourses and other public functions for benefit of the community in general and to acquire property for such purposes.
 - k. To ensure that the benefits under the objectives of the trust are made available to all irrespective of caste, creed, religion, sex or any other kind of bias or discrimination.
 - l. To acquire land, buildings or any other movable or immovable properties in its own name so as to fulfil the above objects.
 - m. To undertake any other activity in aid of or incidental to the above activities but which are not inconsistent with the above objects.
3. The trust has started a school under the traditional gurukulam system of learning where the teachers and students study and live under the same roof and engage in the learning activity as prescribed in the ancient scriptures.
 4. The first batch of the school consisting of 13 students have been admitted and their education has been commenced. These students come from very deserving economically and socially weak families from the interior rural districts of Bihar, Jharkhand, Uttar

5. Education is made available to the these students entirely free of cost and the entire cost of education of the students met by the trust The students are provided:
 - a. Study materials (notebooks, text books and other materials).
 - b. Qualified teachers for all subjects.
 - c. Clothing and uniform.
 - d. Hostel dormitory for students and quarters for resident teachers and.
 - e. Food for students and teachers.
 - f. Health care and medical care.
 - g. To and fro tickets during annual holiday for the students to visit their parents.
 - h. Communication facilities for students to interact with their parents.
 - i. Physical exercise facilities.
 - j. Library and extra-curricular facilities.
6. The trust has started the process for registering the school under the National Open School regulated by the National Institute of Open Schooling (NIOS) NOIDA, which has recognised systems of education under the Gurukul System and Maharishi Sandipani Rashtriya Vedavidya Prathisthan, Ujjain.
7. The students are provided education is all the school subjects like Mathematics, Sciences, Social Sciences, English, Sanskrit and Mother tongue languages. These subjects are handled by qualified teachers on honorary basis. Students are instructed in the Vedic and Vedantic studies by qualified Vedic Scholars. The students are provided with digital study facility with interactive digital lessons from expert faculty and also study lectures and lessons prepared by qualified teachers recognised by the National Institute of Open Schooling, NOIDA/Maharishi Sandipani Rashtriya Vedavidya Prathisthan, Ujjain
